Dear Mr. Thai:

7. And to repeat what I already mentioned, Dr. Koo will pick you up at your room tomorrow (Wednesday) morning at about 10:40.

If I do not say so before, I will see you tomorrow at lunch in the Michigan Room at Kellogg Center after Dr. Koo's class.
