We wish to express our appreciation for your making the arrangements for Mr. Ton That Trach's visit to Window Rock.

As you probably know, the Vietnamese are currently trying to improve the circumstances of a minority group inhabiting their highlands. Perhaps you might appreciate the relevant story that has been told to us by the son of American missionaries in Vietnam: a village which seemed to have favorable leanings towards Christianity was approached and agreed that they thought this a very fine idea but it would have to be delayed until the following year. The reason: it was their turn to host the surrounding villagers and this would, of course, include sacrificing much of the livestock for this occasion.

The interest in work of the Bureau of Indian Affairs stems from a hope that perhaps their own problems can be alleviated.
